"SCENARIOS FOR THE FUTURE OF ISRAEL IN 2048" CONFERENCE

On November 10-11, the Meltzer Schwartzberg Center for Israel Studies (CIS) and Kogod School of Business (KSB) hosted an international conference, "Israel at 100: Scenarios for the Future of Israel in 2048." A dozen speakers, many from Israel, presented scenarios for what Israel will look like on the 100th anniversary of its founding. CIS Director Michael Brenner, who co-chaired the conference with KSB Professor Erran Carmel, opened the proceedings with a reminder that Israel itself grew out of the utopian vision of Theodor Herzl. Carmel brought with him a crystal ball to visually remind the audience to forget the present and put on their futures caps when listening to the scenarios presented. They covered aspects such as religiosity, climate sustainability, Palestinian-Jewish and Arab-Israel relations, "startup nation" economy, and connections with Diaspora Jewry.

Opening keynote speaker, futurist David Passig, forecast a "Demographic Dividend," whereby in

2048 Israel will have 12 million Jews along with 4 million non-Jews. A key to Passig's optimistic economic scenario was that 30% of ultraorthodox Jews will drop out from the Haredi community and become strongly integrated in the country's society.

Eugene Kandel proposed a dramatic shift in Israel's governance structure to a Federalist model to stave off what he sees as an otherwise inevitable collapse of the state. His creative scenario proposed three "layers" for society who share foundational values, one for liberal democratic Jews, one for religious nationalist Jews and one for an Arab-Jewish society of all citizens. A retired professor of economics and finance at Hebrew University, Kandel was a former Head of Israel's Economic Council.

Among pessimistic scenarios were a "Nuclearized Middle East" by Yoel Guzansky and Anwar Mahajne's "Ethno-Nationalism Wins," whereby "Arabs have less access to

technology, and fall further behind." Several presenters predicted new leadership in Israel and collaboration among countries to solve problems, such as Eyal Hulata's "Pragmatic Regional Alliance," Tsvi Bisk's "Israel Becomes Super Massachusetts," and Shira Efron's "Climate Change: Opportunity Multiplier."

FROM THE DIRECTORS

More than one year after the October 7 massacre, Israelis and Palestinians live in a different reality. They experience terror and war every day, and the chances for peace seem slimmer than ever. As we all witnessed, the events in Israel and Gaza had long-term repercussions on American campuses. What does this mean for Israel and Jewish Studies at AU? Can we do business as usual in a climate in which Jewish students feel threatened, Zionism is equated with racism, and Israel vilified as an illegitimate settler colonial state?

As we see science and academic work increasingly questioned and replaced by pseudo-truths and populist opinions, we strongly continue to believe in the mission of education. While we realize that promoting knowledge is not sufficient to fight antisemitism, we also know that this fight will be lost if we give up spreading knowledge. The Center for Israel Studies and the Jewish Studies Program refuse to swap scholarship for activism and research for propaganda. Our mission is to teach our students, excel in research, and engage with our community in a meaningful dialogue.

During the recent academic year, we have done so in manifold ways. We organized a lecture series on antisemitism; we held a conference on the future of Israel; we brought scholars, diplomats, and politicians with a broad range of views and different backgrounds. Our speakers included Jews and Muslims, Palestinians and Egyptians, Ethiopian-Israelis and Russian-Israelis, Americans and Europeans. We heard from family members of October 7 victims, and we were hosted by the Ambassador of Ukraine. Our students continued to excel in their academic work and, after graduation, in the professional world. While the challenges to our missions are growing, we will increase our efforts to promote knowledge and help to make our campus a welcoming place for every student.

ISRAELI CULTURE, LITERATURE AND POLITICS

GLOBAL ISRAEL: UKRAINE-ISRAEL RELATIONS

March saw the return of our students' favorite CIS event, our Global Israel Series of visits to foreign embassies. Ukrainian Ambassador Oksana Makarova welcomed AU students to Ukraine House to discuss Ukraine-Israel relations in the rich historical and contemporary contexts. She commented that Israel and Ukraine were the only two countries in the world with both a Jewish prime minister and president. She also underlined that Israel and Ukraine are similarly under attack by their enemies. CIS Director Michael Brenner moderated the discussion, which featured Ukrainian counselor Dr. Kateryna Smagliy, Israeli Embassy political officer Nadav Zysblat, and historian Vadim Altskan from the United States Holocaust Memorial Museum. The discussion was followed by a delicious Ukrainian supper.

In a continuation of the Center for Israel Studies and Jewish Studies Program's Israeli Writers Series, Professor Lauren Strauss interviewed best-selling writers Ayelet Gundar-Goshen (*Waking Lions*, 2015 and *The Wolf Hunt*, 2023), and Etgar Keret (*Auto Correct*, 2025). Gundar-Goshen, an award-winning novelist and a clinical psychologist, spoke in February about trauma and recovery in her literary and therapeutic work. Keret, whose many books have been translated into over 40 languages, visited AU in September. Like Gundar-Goshen, Keret spoke about the trauma experienced by mental health professionals. He shared his conviction that creativity, imagination and story-telling are survival tools, remarking: "telling a story is a way to give love when you have nothing else to give."

In February, CIS Director Michael Brenner discussed U.S.-Israel foreign relations with Ambassador Dennis Ross, a diplomat and peace negotiator under Presidents G.H.W. Bush, Clinton and Obama. The event, the postponed 2023 Helen and Daniel Sonenshine Lecture, was co-sponsored by the Meltzer Schwartzberg Center for Israel Studies, Kogod School of Business and Sine Institute of Policy and Politics. The standing room only event was held in the AU Museum, amidst the exhibition "Art and the Demands of Memory Works by Second Generation Holocaust Survivors." The exhibition featured art from local Israeli artist Dalya Luttwak and Mindy Weisel.

READING HERZL IN BEIRUT

Princeton Professor Jonathan Gribetz delivered the 2024 Helen and Daniel Sonenshine Lecture on October 21 on his book, *Reading Herzl in Beirut*. Gribetz explores why the PLO invested in research about the Jews, what its researchers at the PLO Research Center learned about Judaism and Zionism, and how their knowledge in "enemy studies" informed the PLO's relationship to Israel. The PLO Research Center was established in 1965 and expelled from Lebanon in 1983.

BLACKNESS IN ISRAEL

Zawdu is working on a project examining the changing relations between ethnic culture and skin color among Ethiopian Israelis, from the early years of migration to present day.

This motivated her to co-lead AU's first itrek trip in March 2023, where she and two of her peers led 40 graduate students on a policy-focused program of Israel. Following her time as Senior Research Analyst at AIPAC, in October 2023 she was named Assistant Director of Policy & Advocacy at the Conference of Presidents of Major American Jewish Organizations where she focuses on advocating for the return of the hostages held captive in Gaza, antisemitism policy in the U.S. and abroad, the U.S.-Israel relationship, and the relations of Jewish diaspora groups.

Kelly says her interest in Jewish Studies was sparked by an independent study she did with Professor Pam Nadell, who wrote her current job recommendation. "It was incredible to have a one-on-one with a real thought leader in Modern Jewish History," says Rabbi Whitehead.

FACULTY NOTES

Dan Arbell, Israel Studies Scholar in Residence, College of Arts and Sciences (CAS), is an associate fellow at the International Institute for Strategic Studies-Americas. Since October 7 he has done numerous interviews and provided commentary in leading US and international media outlets.

Boaz Atzili, School of International Service (SIS), presented "Defenders of Democracy? Israeli Reservist and Resistance to Democratic Backsliding" (with Manaswini Ramkumar), at the International Studies Association IS-ISSS Joint Conference in Colorado Springs, October 2023 (under review for publication). He contributed "Sacrificed on the Alter of Netanyahu's Political Power," in *Benjamin Netanyahu's Dark Legacy: The Abandonment of October 7th Hostages* (Forum For Life, Washington DC: 2024). Atzili was interviewed widely on CNN, MSNBC, FOX, NPR, and others and contributed a number of opeds and policy articles on the October 7th Hamas attack.

Michael Brenner, Department of History, (CAS) was awarded the Cultural Prize of Honor of the City of Munich in June, 2024, for his lifetime achievement. He published "The Wall and the Mountain: Symbols of Two Israels," in a recent volume on *New Perspectives on European Jewish History*. He continues to serve as a member of the Commission of the German Government to Reappraise the Terror Attack at the Munich Olympics 1972 as well as a board member of the Hebrew University's Franz Rosenzweig Research Center and the DAAD Institute for German Studies at Haifa University.

Nathalie Japkowicz, Department of Computer Science (CAS), is leading a project along with Wendy Melillo (SOC) and Jeff Gill (SPA/ CAS) entitled "Unmasking Antisemitism". The project uses lexical analysis and AI technology to discover emergent coded antisemitic terminology and antisemitic tropes.

Julie Keresztes, Postdoctoral Fellow, Department of History-Jewish Studies Program (CAS), will publish her first book, *Photography and the Making of the Nazi Racial Community*, in January 2025 with Cornell University Press in association with the United States Holocaust Memorial Museum.

Alan Kraut, Department of History (CAS), authored an essay, "Mass Migration and Immigration Policy" which will appear in the forthcoming *Oxford Handbook of American Jewish History* edited by Michael R. Cohen and Shari Rabin. Kraut serves on the Executive Committee of the National History Coalition and continues to chair the History Advisory Committee (HAC) of the Statue of Liberty-Ellis Island Founation.

Lisa Leff, Department of History (CAS), continues to serve as director of the Mandel Center for Advanced Holocaust Studies at the United States Holocaust Memorial Museum. Leff widely presented her research about post-Holocaust restitution of Jewish property looted by the Nazis. She serves on the Executive Committee of the American Academy for Jewish Research.

Manaswini Ramkumar, SIS PhD Candidate, joined CIS as a Research Fellow in Fall 2023. With Prof. Boaz Atzili (SIS), she cowrote an article manuscript titled, "Defenders of Democracy? Israeli Reservists and Resistance to Democratic Backsliding," and presented a draft at the ISA-ISSS Conference at the US Air Force Academy in Colorado Springs in October 2023. Jeffrey Sosland, Washington Semester Program, School of Public Affairs, has been quoted multiple times in the European weekly, *Expresso* after the October 7 Hamas attack on Israel, he. He was also a consultant to the editors of DK Press (part of Penguin Random House) for maps and history about the Arab-Israeli Conflict.

Lauren Strauss, Jewish Studies Program (CAS), served as historian and is featured in the 2024 film, *The Catskills*. She participated in a widely attended webinar on "Teaching About Israel in the Current Moment," organized by University of Maryland and spoke about DEI and antisemitism to a standing room only crowd at Association for Jewish Studies annual conference. She continues to serve on the boards of the Association for Jewish Studies, Heart of a Nation (Israeli-Palestinian-American dialogue group), and is co-chair of the Greater Washington Forum on Israeli Arab issues.

Efrat Yerday, Seymour and Lillian Abensohn Visiting Israeli Professor (CAS) taught "Blackness in Israeli Popular Culture and Contemporary Art" in fall 2023 and "Israeli Society" in Fall 2024. She published "Softening the Gaze: Between Sexual Harassment and Racial Harassment" in the journal *Theory and Criticism* (59) of the Van Leer Institute, Jerusalem.

Guy Ziv (SIS) received two awards from SIS, the SIS Faculty Exceptional Research Award (FERA) – Summer 2024 and the SIS Outstanding Scholarship, Research, Creative Activity, and Other Professional Contributions Award, American University, 2024. He has had dozens of media interviews focused on the October 7 Hamas Massacre and Gaza War in outlets including BBC, CNN, MSNBC, and NPR.

GUY ZIV BOOK LAUNCH: NETANYAHU VS THE GENERALS



AU's School of International Service and the Meltzer Schwartzberg Center for Israel Studies hosted a timely book launch for Professor Guy Ziv's new book, *Netanyahu vs The Generals: The Battle for Israel's Future* (Cambridge University Press, 2024). In the book, Ziv sets out to explain the mutual distrust and intense disagreements between Netanyahu and the security community, as well as the un-

derlying reasons behind the Israeli public's inattention to the collective judgment of hundreds of ex-generals and former spymasters. Professor Ziv toured widely at universities in the U.S. and abroad talking about the book, including at the Association for Israel Studies annual conference in Prague (July 2024).

PAM NADELL'S CONGRESSIONAL TESTIMONY



Pamela Nadell, Patrick Clendenen Chair in Women's and Gender History, testified before Congress for the third time in December on antisemitism on college campuses, along with three Ivy League Presidents. Nadell's testimony covered antisemitism's classic tropes and canards, noting that "antisemitism visible on colleges and universities

today is just part of the toxic stew of antisemitism Jews in the US now face." Nadell's expert testimony elevated the work of AU's Jewish Studies Program internationally, as will her new book, *Antisemitism, an American Tradition* (expected fall, 2024). Nadell previously won the National Jewish Book Award for her book, *America's Jewish Women: A History from Colonial Times to Today.*

"ANTISEMITISM: A POLITICAL TRADITION" FALL SERIES

In the Fall of 2024, scholars from CIS, Jewish Studies, and beyond joined forces to present a wide-ranging series of one-hour lectures on antisemitism. The series, organized by Professor Lauren Strauss, drew on the speakers' areas of expertise to explore the history of modern antisemitism and anti-Jewish hatred in America and Nazi Germany, as well as hate across the internet and embedded in imagery of diseases and racial stereotypes. The webinars enabled us to reach hundreds of viewers during the talks, and even more who watched the recorded sessions afterward. Although the subject of antisemitism has been addressed by many outlets in recent years, our series stands out for its unique approach that puts the topic in a political context, and the deep learning reflected in each lecture.
