Coverage Options & Cost

AU contributes towards medical and dental costs. AU's contributions and your cost for <u>medical coverage</u> are based on your annual salary.

Paid Leave

- Annual leave (vacation)
 - 12 days in year 1
 - 15 days in years 2-4
 - 21 days in years 4+
- 13 paid <u>holidays</u> each year, including the week off between Christmas and New Year's Day
- Paid time off to care for you and your family
 - · 12 days of sick leave per year
 - Short term medical leave and long term disability insurance
 - DC Paid Family Leave
 - <u>Parental leave</u> to bond with a new child in your home
 - Bereavement leave
- <u>Other paid leave</u>, including jury duty and military leave

Retirement Savings

- 2 to 1 match up to 10% of salary in <u>AU's 403(b)</u> <u>Retirement Plan</u> when you've worked with AU for a year
- If you've worked at another university or other 501(c)(3) non-profit, you may be eligible for a waiver of the one-year waiting period

Education Benefits

- <u>Tuition remission</u> for you and your spouse or domestic partner after successfully completing the probation period
- Education scholarships for your dependent children after two years of employment
