Collection Description

Biographical Note

James Michel (b. 1939–) served in the United States Agency for International Development (USAID) between 1990 and 2000. After his departure, Michel worked as a private consultant in international development. Prior to working at USAID, Michel attended St. Louis University and earned a degree in Legal Studies; he also attended law school and earned his Juris Doctor.

Michel joined the U.S. State Department in the Office of the Legal Advisor in 1965. In 1970, he was moved to the field of political military affairs, where he worked as a lawyer for the State Department. In approximately 1972, Michel was promoted to Assistant Legal Advisor for Political-Military Affairs in the Office of the Legal Advisor. Michel also worked in the Office of the Under Secretary for Security Assistance between 1975 and 1977. Michel parted from both his position as Assistant Legal Advisor and Security Assistance in 1977 and began work in the Office of the Legal Advisor as a Deputy Legal Advisor. Michel was then promoted to Acting Legal Advisor in 1980. In 1982, he left the Office completely and began work in a different State Department branch as Deputy Assistant Secretary for Inter-American Affairs in 1983. After serving as Deputy Assistant until 1987, Michel then joined the U.S. State Department's Diplomatic Affairs Divion as an Ambassador to Guatemala between 1987 and 1989.

After his tour as an Ambassador, USAID reached out to Michel and offered him a position in their Latin American and Caribbean Bureau (LAC) as the Acting Administrator for Latin American Affairs. In this position, Michel set up offices within the Bureau on trade and investment and democratic initiatives with office directors. Michel served in this position until 1993, when he began his role as the U.S. Representative in the Development Assistance Committee (DAC) at the Organization for Economic Cooperation and Development (OECD), an international development organization. In this position, Michel worked with other representatives in Paris, France to stimulate economic progress and world trade. He held this position between 1994 and 1999 when he was promoted to the role of Counselor to the USAID. As Counselor, Michel contributed to administrative transition work, briefing books, and managed multiple bureaus. He left this role in 2000 and began work as an independent consultant for international development.

Collection Scope and Content Note

This collection documents James Michel's career as a USAID employee between 1990 and 2000 as well as his service in the OECD between 1994 to 1999 and his work as an International Development Independent Consultant starting in 2000. The collection includes publications, assessments, notes and statements, project papers, and action plans. Each series documents perspectives of working in different international development organizations.

The bulk of this collection contains materials related to Michel's documentation of USAID and its promotion of democratic governance and the rule of law. He both collected and produced materials that focused on the promotion of democracy, justice, and rule of law in Latin America and the Caribbean. The materials in this collection are textual and include books, studies, program assessments and proposals, presentations, and conference summaries.

Series Descriptions and Collection Contents

Series 1: Documentary Record of USAID, 1968-2022

The Documentary Record of USAID series (1968-2022) includes collected materials documenting USAID's decades of work in Latin America and the Caribbean trying to promote democratic practices, good governance, and the rule of law. The Agency worked on generating better systems of justice across these regions as well as getting citizens more involved with politics and voting. Through programs such as The Democratic Initiative, Michel and USAID focused their efforts on strengthening democratic institutions, integrating democracy into the USAID program, rewarding progress in democratization, and establishing rapid-response mechanisms to enable timely responses to democratic breakthroughs and unanticipated needs. Materials in this series include books, action plans, project assessments, and research studies collected and produced by James Michel.
