4. RESEARCH CONTRIBUTIONS

4.1 Important Contributions

4.1.1. Hydropolitical Peacebuilding

The principal contribution my work has made to the field of peacebuilding, conflict transformation and hydropolitics is in developing a framework for research in 'hydropolitical peacebuilding'.

My Doctoral dissertation, entitled 'Hydropolitical peacebuilding: Israeli-Palestinian water relations and the transformation of asymmetric conflict in the Middle East' discursively analyses Israel's hydrohegemonic relations with the Palestinians. It also leverages the methodology of interpretive practice to examine and analyse civil society hydropolitical practices for their peacebuilding significance.

This research has led to several academic publications and numerous conference presentations.

4.1.2. Peace and Conflict Impact Assessment (PCIA)

The Doctoral research which I have undertaken on hydropolitical peacebuilding in the Middle East provided the basis for consultancy work with the World Bank. Leveraging this framework for analysis and intervention, I conducted a peace and conflict impact assessment of the \$5 billion Red Sea Dead Sea Conveyance, informing the project's feasibility study process.

Further theorising PCIA, as Co-Principal Investigator, I secured funds from IDRC-Canada to conduct a two-year research project entitled 'Assessing the Impacts of Peace and Conflict Impact Assessment (PCIA): A North-South Participatory Research Project'. This is a collaborative initiative directed by Peacebuild Canada and Peacemedia-paixmédia, in association with York University's Institute in Research and Innovation in Sustainability (IRIS) and the *Journal of Peacebuilding and Development* (JPD).

As Visiting Editor, I am spearheading the publication of a special Issue of the *Journal of Peacebuilding and Development* (Spring 2014) on PCIA with participant contributors from the Global South and North.

4.1.3. Graduate Practicum on Water, Cooperation and Peace in the Middle EastAs Professorial Lecturer at the School of International Service (SIS), American University (AU, Washington DC), I have led the development and implementation of a Graduate Practicum on Water, Cooperation and Peace in the Middle East.

Launched in Spring-Summer 2013 (and planned again for Spring-Summer 2014), this practicum provided extensive methodological, theoretical, analytical and fieldwork training to graduate students. These students then constructed a multi-faceted 'environmental peacebuilding' framework and conducted a rapid appraisal of transboundary, cooperative water-related practices on-site in Israel and Palestine. Subsequently, they published a 100+ page environmental peacebuilding assessment of these practices. The report is available at: http://www.american.edu/sis/gep/upload/Practicum-2013-Final-Report-Water-Cooperation-ME.pdf Findings from this practicum were shared with water and cooperation practitioners in the Middle East as a way of reflexively informing their work.

This practicum provides a methodology for faculty and students to work together in conducting environmental and hydropolitical peacebuilding assessments leading to publications that make a meaningful contribution to the fields of research and practice.

Additionally, while leading this practicum, I was one of three people that worked on the development of a *Graduate Certification in Environment, Peace and Conflict Resolution* at AU-SIS. This Certificate has officially been adopted by the university and is one course available to students towards completion of Certificate and Degree requirements.

4.1.4. Children and Youth in Armed Conflict

While working at London-based international conflict resolution organisation International Alert in the mid-1990s, I received funding from the Commonwealth Secretariat to co-author a Monograph on the role of young people in conflict and peacemaking. The publication, *Up In Arms*, was widely circulated to participants at youth leadership conferences organised by the Commonwealth Secretariat. It contributed to moving the discourse from representing young people solely as victims of armed conflict (e.g. as child soldiers) to agents of peaceful transformation.

Building on this work, in 1998-2001, and in collaboration with the Montreal-based International Bureau for Children's Rights (IBCR), I secured funding from CIDA to produce a publication entitled *Rites of Peace: Responding to the Rights of Children in Armed Conflicts*. This magazine/journal published academic articles, popular narratives, organisational methodologies, photography and other cultural forms, advancing the discourse of children's rights and agency in conflict environments. It discursively and politically informed the work of the Working Group on Children in Armed Conflicts of the Canadian Peacebuilding Coordinating Committee and of people and organisations in 103 countries.

4.1.5. Cantilevers Peace and Conflict Transformation Magazine

In the 1990s, the field of peacebuilding and conflict transformation was emerging in the wake of the Cold War, primarily situated within mutlilateral, NGO and professional circles. Intent on broadening awareness of the immense and innovative work being undertaken in this field, a colleague and I launched *Cantilevers* magazine.

Between 1996 and 2001, we bi-annually published the experience of peacebuilding and conflict transformation practitioners in an accessible magazine format of 64-pages. Methodologically, we based ourselves in conflict environments over months, identified people undertaking innovative work on the ground, and then worked with them to publish their work. We established roving editorial offices in Israel, Palestine, Jordan, Bangladesh, India, South Africa, Zimbabwe, Canada (Montreal) and the United States (Washington DC).

This magazine directly spawned the *Journal of Peacebuilding and Development*, launched in 2002.
