(De)Colonizing Indigenous Imaginaries in Latin American Cinema

Indigenous peoples have been represented in different ways in Latin American films, depending on filmmaking perceptions but also, and more importantly for the purpose of this project, on political agendas. *(De)Colonizing Indigenous Imaginaries in Latin American Cinema* explores the portrayal of indigenous peoples in Latin American cinema as part of national discourses that have been efficiently delivered to popular audiences to foster political domestic agendas. While there has been extensive research on Latin American cinema and politics, scarce investigation has been carried out tackling the role of indigenous communities and individuals in the representation of Latin American societies. In this sense, my new book sheds light on the powerful impact of cinema in cementing longstanding, preconceived ideas as well as advancing political agendas. Moreover, although my book focuses on fictional films, it aims at establishing a dialogue with recent research on indigenous self-representation through audiovisuals and documentaries as powerful tools that go hand in hand with indigenous activism and the fostering of indigeneity; in

other words, the representation of indigenous peoples from within, from their own lenses and locus. *(De) Colonizing Indigenous Imaginaries in Latin American Cinema* focuses on the countries I have conducted research over the last twenty years, Peru first, then Mexico, and later Bolivia. The book opens new avenue by incorporating Colombia, Guatemala, Ecuador and Paraguay.
