Robert A. Blecker is Professor of Economics at American University (AU), Washington, DC, USA. He is also Affiliated Faculty of AU's School of International Service (SIS) and Center for Latin American and Latino Studies (CLALS), a Research Associate at the Economic Policy Institute (Washington, DC), and a Fellow of the Forum for Macroeconomics and Macroeconomic Policy (FMM, Düsseldorf/Berlin, Germany). He is a member of the editorial or advisory boards of the *International Review of Applied Economics*, *Metroeconomica*, *Review of Keynesian Economics*, *European Journal of Economics and Economic Policies: Intervention*, *Investigación Económica*, and *Review of Political Economy*. His most recent book is *Heterodox Macroeconomics: Models of Demand, Distribution and Growth* (co-authored with Mark Setterfield; Cheltenham, UK, and Northampton, MA, USA: Edward Elgar Publishing, Ltd., 2019). His earlier books include *Fundamentals of U.S. Foreign Trade Policy: Economics, Politics, Laws, and Issues* (co-authored with Stephen D. Cohen and Peter D. Whitney; 2nd edition, Westview, 2003); *Taming Global Finance: A Better Architecture for Growth and Equity* (Economic Policy Institute, 1999), and *U.S. Trade Policy and Global Growth* (edited volume, M. E. Sharpe, Inc., 1996).

Professor Blecker's articles have appeared in numerous refereed academic journals, including the *Cambridge Journal of Economics*, *Economica*, *European Journal of Economics and Economic Policy: Intervention*, *International Review of Applied Economics*, *International Journal of Political Economy*, *Journal of Development Studies*, *Journal of Post Keynesian Economics*, *Metroeconomica*, *Review of Development Economics*, *Review of Keynesian Economics*, *Structural Change and Economic Dynamics*, *Weltwirtschaftliches Archiv (Review of World Economics)*, and *World Development*, as well as in edited books and conference volumes published by Cambridge University Press, Oxford University Press, University of Michigan Press, Routledge, Palgrave Macmillan, and Edward Elgar (among others). He has lectured at universities, conferences, and research institutes in various countries including Argentina, Brazil, Canada, Chile, Colombia, France, Germany, Italy, Republic of Korea, Mexico, Peru, and the United Kingdom. His research includes work on heterodox (post-Keynesian and neo-Kaleckian) macroeconomic theory, open economy macroeconomics, international trade theory and policy, economic integration in North America, global imbalances and the U.S. trade deficit, the Mexican economy, North-South trade, and export-led growth and the balance-of-payments constraint.

Professor Blecker received his B.A. in economics from Yale University in 1978 and his M.A. and Ph.D. in economics from Stanford University in 1983 and 1987, respectively. He was also a non-matriculated student in the Master's program in economics at El Colegio de México, Mexico City, in 1978-79 under a Fulbright-Hays scholarship. He was chair of the AU Department of Economics from 2008-12. He received AU's faculty award for Outstanding Teaching in a Full-time Appointment in 2005 and the award for Outstanding Service to the University Community in 2014.
